



I, \_\_\_\_\_, as owner of the Mare, \_\_\_\_\_,  
Registration # \_\_\_\_\_ (AQHA/APHA), agree to contract with Amazing Grace Ranch, hereinafter  
known as "Breeder", to breed my mare to the stallion Tomcat Chex, AQHA #4322531, hereinafter known as  
"Stallion" for the fee of \$2,500.00 for a Live Foal during the 2026 breeding season, which begins February  
1, 2026 and ends July 15, 2026, subject to the following terms and conditions:

- ☐ One Mare - \$2,500.00 Breeding Fee; includes (\$700.00) Chute Fee & Next Day Shipped Semen
- ☐ Return Breeding - Chute fee \$700.00 plus a \$300.00 Next Day Shipping fee.
- ☐ Additional Shipment of Semen - \$550.00
- ☐

**This service is subject to the following:**

- 1) Breeding Fee & Chute Fee must be paid in full prior to first semen shipment payable to Amazing Grace Ranch.
- 2) Mare must be in a healthy and sound breeding condition. Mare Owner agrees to provide a photocopy of the mare's registration papers prior to breeding.
- 3) Mare Owner agrees to notify Amazing Grace Ranch the mare's pregnancy status, in writing, within 45 days of insemination.
- 4) If the mare aborts or fails to conceive, she may return during the 2027 Breeding Season, provided all fees have been paid during the 2026 season.
- 5) Live Foal guarantee. Stallion Fee is for one Live Foal. A Live Foal is defined as one that will stand and nurse. If the foal is born dead, Mare Owner agrees to furnish to the stallion owner, within seven (7) days, a veterinarian's certificate describing the occurrence. In such a case, return privileges will be available for the 2027 breeding season. Breeding fee will not be refunded. Our goal is to get you a Tomcat Chex baby!
- 6) If the Mare Owner fails to return the mare for breeding the following year, then all fees paid shall be forfeited, the right to rebreed is canceled and the Stallion Owner is released from all further obligation of the contract, unless otherwise agreed to in writing and signed by all parties.
- 7) If the mare dies or becomes unfit to breed, the Mare Owner may return during this season or the following seasons with a suitable mare approved by the Stallion Owner.
- 8) Should the Stallion die or become unfit for service for any reason, then this contract shall become null and void and both parties are relieved of any further obligation hereunder, and any monies paid by the Mare Owner toward the Stallion Fee, except the non-refundable Chute Fee of \$700. Shall be refunded to the Mare Owner if the mare is not pregnant or would otherwise qualify for rebreed privileges under this contract. Amazing Grace Ranch reserves the right to fulfill this contract using available frozen semen.
- 9) Mares on the premises of Amazing Grace Ranch have breeding priority on any given breeding day. Therefore, Amazing Grace Ranch makes no guarantee that cooled semen will be available for a specific day.
- 10) Amazing Grace Ranch only assumes responsibility to ship semen in viable condition and shall not be held liable for contamination of semen during or after shipment, loss of viability, or any costs arising from shipments delayed, damaged, or lost in transit. Amazing Grace Ranch does not guarantee the fertility of Stallion but agrees to process each ejaculate to optimize 24-hour post cool motility and subsequent fertility. Every effort should be made to inseminate the mare within 24 hours after collection from the Stallion. Mare Owner agrees to use all cooled semen provided by the Agreement for the mare named in this Agreement and no other.

- 11) Amazing Grace Ranch requires that all cooled semen expenses be paid in advance of shipment. Mare Owner may deposit additional funds with Amazing Grace Ranch. Monthly statements will be mailed for services provided and charges made, or deposits used. If any statement becomes more than 30 days overdue all obligations of stallion owner shall cease, and the unpaid amount will be subject to a finance charge of 1.5% per month or the maximum rate allowed by law.

**A semen shipment includes the cost of the collection and evaluation of the semen. The following semen shipment charges will apply:**

- 1) The Breeding Fee will include one (1) Fed Ex semen shipment. Courier charges \$300.00. Any subsequent shipments, if necessary, must be paid in advance by the Mare Owner at \$550.00 per shipment.
- 2) Rebreeds: All rebreeds will pay a \$700.00 Chute Fee plus \$300.00 Next Day Shipped Semen. Any subsequent shipments, if necessary, must be paid in advance by the Mare Owner at \$550.00 per shipment.
- 3) Donated Breeding: Donated breeding will pay a \$700.00 Chute Fee and \$300.00 Shipping fee which includes Next Day Shipped Semen. If frozen semen is required, there will be an additional cost. Additional cost may apply depending on location of ship to address and or airport carrier charges.
- 4) Embryo Transfers: Mare Owner agrees to notify Amazing Grace Ranch if this is an embryo transfer mare. In the event of multiple embryos from a single flush, Mare Owner agrees to pay a stallion fee of \$2500.00 for each additional Live Foal. An Additional Breeders' Certificate will be issued upon receipt of stallion fee.
- 5) International Fees: International shipments will be charged actual shipping, customs and duty fees that exceed the normal cost for shipping within the domestic United States.

**For On-Site Breedings:**

- 1) Upon arrival, please have the following: (a) current negative Coggins and health certificate papers (if out of state horse); (b) copy of registration papers, front and back; (c) signed contract (d) farrier, worming and immunization records. Failure to furnish these health certificates will constitute authorization for Amazing Grace Ranch to perform such services as deemed necessary for the mare's well-being and will be at the Mare Owner's expense.
- 2) Mare Owners will be responsible for the costs of all ultrasounds, inseminations, stallion collections and semen processing for mares that are bred on site. Mare Owners will also be responsible for all veterinary and/or unlicensed technician expense and will be billed directly by veterinarian and/or unlicensed technician.
- 3) The Stallion Breeding Fee shall be payable when the mare is pronounced safe in foal or prior to mare being picked up, whichever is earlier. All other expenses, including board, shall be payable monthly and shall be paid in full at or before the time mare is picked up from Amazing Grace Ranch.
- 4) Foaling Mares at Amazing Grace Ranch: Mare Owner agrees to pay the foaling fee listed in the Fee Schedule in order to have the mare foal on the premises. All veterinary and/or unlicensed technician expenses incurred in connection with the foaling shall be paid by the Mare Owner, in addition to the foaling fee.
- 5) Amazing Grace Ranch agrees to provide a suitable facility for the care and feeding of the mare and/or foal while at Amazing Grace Ranch. Mare Owner agrees to the rates listed in the Fee Schedule. Mare Owner agrees to pay all boarding and veterinary expenses incurred by the mare and/or foal while under the care of Amazing Grace Ranch. All expenses are due and payable on or before the mare and/or foal departs Amazing Grace Ranch.
- 6) Mares coming to Amazing Grace Ranch for breeding that have purchased a donated breeding will pay the \$700.00 Chute Fee payable to Amazing Grace Ranch and be responsible for all veterinary reproductive expenses which will be performed and billed directly by a veterinarian or unlicensed technician.

**Breeding Arrangements:**

- 1) Stallion is collected on Monday, Wednesday & Friday. It is the responsibility of the Mare Owner and his/her veterinarian to confirm the breeding days.
- 2) Mare Owner must give a 24-hour advance notice to Amazing Grace Ranch (707-480-6543) prior to actual shipment. If Mare Owners veterinarian, after checking the mare to be bred, feels that a Monday shipment will be necessary, Mare Owner must contact Amazing Grace Ranch by NOON Saturday. All cancellations must be made by 8:00 a.m. the day of collection.
- 3) In the case of subsequent shipments, the shipping container, and any additional shipping fees (see above) must be received by Amazing Grace Ranch before the next shipment will be sent. Every effort will be made to accommodate your mare's breeding time frame. However, it is the Mare Owner's responsibility to contact Amazing Grace Ranch so that your veterinarian can get your mare in foal in a timely manner.

- 4) Mare Owner agrees to comply with all appropriate Breed Registry requirements concerning the use and handling of cooled semen. Consequently, it is the Mare Owner's responsibility to return the signed Semen Collection/Insemination Certificate to Amazing Grace Ranch and forward a signed copy of the certificate to the appropriate Breed Registry.
- 5) Failure to adhere to these requirements may result in missed heats and delayed shipments at the Mare Owners expense. Insemination must be done by a veterinarian or unlicensed technician knowledgeable in successful equine insemination techniques.

#### Receiving Transported Semen:

Amazing Grace Ranch is equipped to receive semen transported from other stallions for breeding your mare on site. A handling fee of \$150.00 per mare will be billed to Mare Owner for tracking mare heat cycle and coordinating semen shipments. All reproductive palpations, inseminations, and ultrasound charges will be performed and billed directly to the mare owner by a veterinarian or unlicensed technician.

This contract shall be binding upon the parties hereto, upon execution hereof, and may not be altered or amended, except by a written consenting signed by all parties here to. There will be no exceptions to the terms of this contract and is not transferable unless provided for in writing and signed by all parties. The parties hereto specifically agree that this Agreement shall be construed, governed, and interpreted by and in accordance with the internal laws of the State of California, and the proper place of venue shall be Solano County, California.
